



Stencil Planet Wholesale and Credit Agreement and Terms

To gain and maintain wholesale status with Stencil Planet, you must meet the following conditions:

- Maintain a storefront or other form of retail outlet.
- Provide a valid resale or business license/tax number.
- Buy stencils with the intent resell to end-users or use for teaching.
- Submit a wholesale application and gain approval from Stencil Planet.
- Meet minimum order requirements as indicated below under Ordering Terms.

Ordering Terms and Prices:

- Initial order minimum is \$100 at wholesale pricing. Must be pre-paid by check, credit card or COD.
- Subsequent order minimum is \$50 at wholesale pricing.
- Standard wholesale prices are set at 50% off retail prices (60% off when ordering 5 or more of the same stencil) and apply to most stencil products (custom stencils not included). Over-sized stencils and accessories are not sold for wholesale. Large orders of the same design may be priced lower and will be estimated on a per order basis.
- Our stencils are packaged individually in protective plastic sleeves along with detailed stencil instructions. Some stencil products also come with special project tips. The products are ready for retail display with hang tags, that include a picture of the design.
- If approved, invoice credit terms are 30 day net. 1.5% per month will be charged to all past due invoice balances. \$30 will be charged for bad checks.
- Stocked items are usually dispatched within 5 working days. Other stencil products may take 2 weeks to ship.

Please note that Stencil Planet has the right to discontinue any wholesale status in case the stated agreements and terms are not followed.
